The staff member remains under probation period of six months before his/her status is regularized.

The TA will work under direct supervision of designated professionals: Architect, Structural Engineer, and Quantity Surveyor. She/he will assume responsibility of activities assigned to her/him by the supervisor.

- Study and follow all the requirements of the given building project and prepare necessary data collection formats and collect required data and information including prevailing regulatory requirements issued by concerned authorities
- Undertake planning, concept and architectural designs within the purview of building codes and other regulatory measures adopted by concerned authorities
- · Undergo training, orientation and mentoring sessions as scheduled and instructed by the supervisor
- Prepare weekly progress report and submit to the supervisor
- Perform any other tasks as directed and instructed by the Supervisor

## **Candidates Interested in Drafting**

- Undergo training, orientation and mentoring sessions as scheduled and instructed by the supervisor
- Study and follow all relevant concepts, plans and drawings, and workout detailed drawings as instructed by the supervisor
- Communicate and cooperate with the clients, relevant colleagues and receive written approval from the supervisor on any alterations or changes in the concept or designs
- Report and timely communicate the progress of works every week with the amount of work undertaken in the reporting week to the supervisor
- Perform any other tasks as directed and instructed by the Supervisor
